## IMPACT ON THE INDUSTRY(IES) IN WHICH THE APPLICANT WILL BE INVOLVED:

The production will have a positive economic impact on film and television, tourism, lodging, food and beverage industry, transportation, small business, large retail, as well as purchases and rentals of equipment, props and wardrobe, employment of individuals and contribution to local unions.

## STATE FISCAL MATTERS, INCLUDING THE STATE BUDGET (REVENUES & EXPENSES):

The production will spend approximately \$2,000,000 in Rhode Island, with an anticipated tax credit of \$600,000.

"The economic impact of the Motion Picture Tax Credit on RI" per Dr. Edward Mazze's report is that "per every \$1.00 invested in the tax credit, over \$8.00 of economic activity will result."

## FINANCIAL EXPOSURE OF TAXPAYERS & NEGATIVE FORESEEABLE CONTINGENCIES:

As defined by law, the tax credits will be issued only after it has been determined that the production meets all requirements of the Motion Picture Tax Incentive Program. There are no negative foreseeable contingencies.

# APPROXIMATE NUMBER OF FULL-TIME, PART-TIME, TEMPORARY, SEASONAL AND/OR PERMANENT JOBS, INCLUDING CONSTRUCTION, PROJECTED TO BE CREATED:

Approximately 75 to 100 temporary, full-time jobs within Rhode Island will be created.

#### PROJECTED DURATION OF IDENTIFIED CONSTRUCTION JOBS:

Although there will be a small amount of construction within the production, most of the filming will be on location.

Standard union wages will apply. Minimum wage for non-union employees. Approximate hourly wages of \$40 to \$11.50 per hour.

Standard union benefits for health, welfare and pensions for IATSE, SAG/AFTRA, DGA, WGA and Teamster agreements.

#### PROJECTED FISCAL IMPACT ON INCREASED PERSONAL INCOME TAXES TO THE STATE OF RI:

All employees receiving a wage in Rhode Island will pay personal income tax based on their income. Detailed expenditures of individual employees and loan out companies will be sent directly to The Division of Taxation by the production.
