You can use Form RI-4868 PT to obtain an automatic 6 month extension of time to file your Rhode Island Pass-through Withholding Tax Return.

#### **GENERAL INSTRUCTIONS**

Use Form RI-4868PT to apply for 6 more months to file Form RI-1096PT, Rhode Island Pass-through Withholding Tax Return.

# **EXTENSION OF TIME**

The Rhode Island extension form does not need to be filed if you are not required to make payment with Rhode Island extension form.

If you must file a Rhode Island request for extension, you should:

- 1. Prepare the Rhode Island Extension Form RI-4868PT
- Clearly show the full amount properly estimated as Rhode Island tax for the year 2022.
- 3. File the extension with the Rhode Island Division of Taxation on or before the due date for filing the Rhode Island Pass-through Withholding Tax Return.
  - The extension must be filed by the 15th day of the third month following the close of the entity's taxable year (March 15, 2023 for a calendar year entity).
  - Trusts must file on or before the fifteenth day of the fourth month following the close of the entity's taxable year.
- 4. Pay the amount of Rhode Island tax due as calculated on Form RI-4868PT by March 15, 2023.
- 5. Be sure to attach a copy of Form RI-4868PT to the back of the Rhode Island return when it is filed.
- 6. Retain the top portion of this form for your records. Detach and return the lower portion with your payment.

## ADDITIONAL INFORMATION

The filing or granting of an extension of time to file does not extend the time for payment of tax due on the return.

Write "Form RI-4868PT", your daytime phone number and the entity's federal employer identification number on your check or money order.
