The production will spend approximately \$2,503,681 in Rhode Island.

Anticipated tax credits are \$751,104.

There have been multiple studies showing the economic impact of stage productions on the local economy and Jorge Elorza, the Mayor of Providence praised Arts Activity for helping to create and sustain jobs for the residents of Rhode Island as well as helping to generate millions in revenue. It also helps to attract tourists and helps to attract and retain businesses, which in turn helps to revitalize the neighborhoods.

## FINANCIAL EXPOSURE OF TAXPAYERS & NEGATIVE FORESEEABLE CONTINGENCIES:

The tax credits will be issued only after it is determined that the production meets all of the requirements of the Motion Picture Tax Incentive Program, as defined by law therefore there are no negative foreseeable contingencies.
