By having these agencies together in one place, attendees will be able to discuss resolution of such issues as tax debts or delinquencies and tax-related license blocks, receive refunds they may not have been aware they are entitled to, and find resources to stay up to date on their legally required filings.

This event is free to attend and open to all taxpayers, both individuals and business entities. Registration is not required, though is encouraged.


