The formula utilized for distributing the scholarship funds is to place all eligible Rhode Island residents in a common pool. The amount of funds available to each is split equally and distributed proportionally through the schools.

When the amounts of scholarships exceed what a family should receive according to the school's scholarship formula, the excess amount is disbursed among remaining eligible students in the school. When that amount is exceeded, the balance of funds is disbursed among remaining eligible students in the other school of this SGO.
