Rhode Island Application for Automatic Extension of Time To File a Rhode Island Composite Tax Return

You can use Form RI-4868C to obtain an automatic 6 month extension of time to file your Rhode Island Composite Tax Return.

GENERAL INSTRUCTIONS

Use Form RI-4868C to apply for 6 more months to file Form RI-1040C, Rhode Island Composite Tax Return.

EXTENSION OF TIME

The Rhode Island extension form need not be filed if you are not required to make payment with Rhode Island extension form.

If you must file a Rhode Island request for extension, you should:

- 1. Prepare the Rhode Island Extension Form RI-4868C.
- Clearly show the full amount properly estimated as Rhode Island tax for the year 2013.
- File the extension with the Rhode Island Division of Taxation on or before the due date for filing the Rhode Island Composite Tax Return.
 - The extension must be filed by the 15th day of the fourth month following the close of the entity's taxable year (April 15, 2014 for a calendar year entity).
- 4. Pay the amount of Rhode Island tax due as calculated on Form RI-4868C by the 15th day of the fourth month following the close of the entity's taxable year (April 15, 2014 for a calendar year entity).
- Be sure to attach a copy of Form RI-4868C to the front of the Rhode Island return when it is filed.
- 6. Retain the top portion of this form for your records. Detach and return the lower portion with your payment.

ADDITIONAL INFORMATION

The filing or granting of an extension of time to file does not extend the time for payment of tax due on the return.

Write "Form RI-4868C", your daytime phone number and the entity's federal identification number on your check or money order.
