This bond shall remain In full force and effect for violation of any condition hereof which occurred prior to the effective date of cancellation, for a period of one year and a day after the expiration of this bond as herein provided, unless a certificate be Issued by the Tax Administrator to the effect that all taxes due to the State have been paid.
